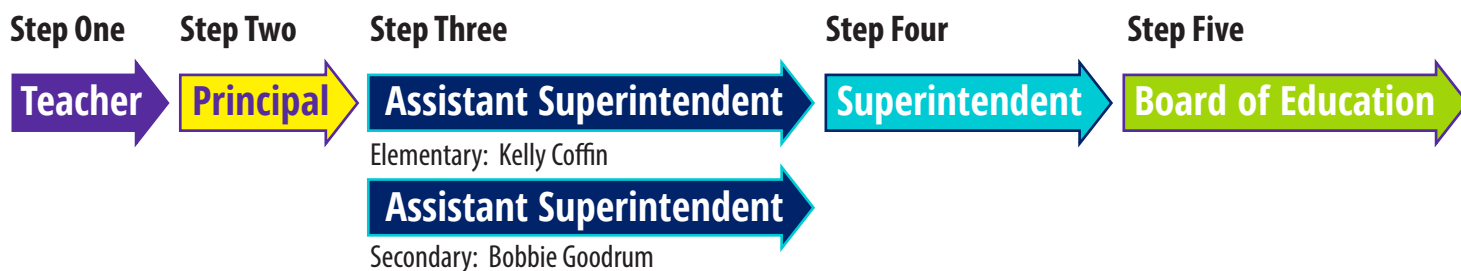


# Channels of Communication
