

That the District reserves the right to review any material stored in files to which all users have acce and will edit or remove any material which the staff, in its sole discretion, believes may be unlawful conveys an offensive, profane, or sexually suggestive message, or harasses or disturbs by pestering tormenting, including, but not limited to, intimidation because of a person's race, color, religion, gendes sexual orientation or ethnicity.
